


Audible Beacon Device

The Audible Beacon Device (ABD) provides percussive tones and/or verbal messaging beneficial to visually impaired and non-visually impaired pedestrians. It can function independently, paired with a pushbutton, or integrated with a Guardian APS unit for advanced broadcast functionality and true destination Beaconing.

The ABD is ideal for larger intersections as well as intersections with no APS devices but need for APS messages or tones.

A 4C cable connects the Signal Power Interface (SPI) inside the pedestrian signal head to the ABD allowing it to operate independently from the cabinet. Adding 2C field wires from the FT connections at the Guardian to the Beacon allows for integrated APS functionality.

In metro applications, the ABD can provide informational messages for transit and light rail applications. The SPI requires 48 or 120 VAC input at the location of installation.

Key Features

- The ABD may be used in conjunction with a pushbutton to provide audible APS indications
- True Destination Beaconing compatible when paired with PedSafety's Guardian APS
- Pan-Tilt bracket provides sound directionality to the closer third of the crossing
- Broadcasts audible indications at timed crossings where there is no actuation
- Two mounting options
 - Mounts on underside of the pedestrian signal head at the pedestrian initiation point of the crosswalk, or
 - Mounts on a pole approximately 7-10 feet high and points into the crossing
- Change settings via PedSafety's PedConnex™ software, free for all users, Bluetooth® and/or PC USB interface
- Bluetooth® included to allow for wireless setting and volume changes through PedSafety's PedConnex™ software
- Ambient Gain Control controls volume levels and adjusts based on surroundings
- Calendar function volume controls accommodate residential and evening time operating envelopes.
- Constructed of durable Polycarbonate / PBT Housing, pan-tilt bracket constructed of 6061 AL
